





1. Sri Venkateswara Degree College, Guntur (M), Guntur District obtained provisional permission from the Competent Authority in the year 2001 for running a new Private Unaided Degree College. The Competent Authority accorded provisional permission to the Society / College in the address entry with a view to provide access to higher education to all sections of the Society and to improve Gross Enrolment Ratio (GER), after identifying the need in the locality and granted permission to the Degree College.

2. 


