

Show Cause No. APSCHE/AC-AU-Not functioning-SCN/2021

Sub: APSCHE – Academic Cell – Andhra University area – Colleges which are holding permission and not functioning for the last three years – Denied the access of higher education to all sections of the Society in the locality concerned – Show Cause Notice to the Colleges issued - Regarding.

ORDER : -

1. Chandrakala Devi Sarada Degree College, Nellimarala, Vizianagaram obtained provisional permission from the Competent Authority in the year 2002 for running a new Private Unaided Degree College. The Competent Authority accorded provisional permission to the Society / College in the address entry with a view to provide access to higher education to all sections of the Society and to improve Gross Enrolment Ratio (GER), after identifying the need in the locality and granted permission to the Degree College.

2. As per 17 (3) of the G.O under reference 4th cited, *the Competent Authority shall be the ultimate authority to withdraw permission/recognition of a private un-aided degree college, un-aided under graduate programmes, un-aided Post graduate programmes, If an affiliated college fails to comply with any of the provisions of the Act or rules or guidelines or observe the conditions of the permission or has conducted itself in a manner prejudicial to the academic and administrative standards and interests of the Competent Authority/Government and the affiliating University*

3. Whereas the Competent Authority noted that the Society / College in the address entry having provisional permission from this Competent Authority has not obtained affiliation for the last three years, which is a pre-requisite to function a college, and thereby the College in the address entry is not functioning for the last three years and denied the access of higher education thereon to all sections of the Society, which lead to disqualifying the locality for being notified while inviting proposals from desirous managements for establishment of new colleges and thereby denying the access of Higher Education in the locality concerned. This conduct of the Society and the College amounts to committing a serious default while still holding permission to run the College from the Competent Authority, thereby monopolising the activity of catering education in the area/locality.

4. As per Rule 17 (12) of G.O. under reference 4th cited, the Competent Authority shall withdraw permission permanently or for any specific period of time, when an institution, including a permanently recognised/affiliated institution has failed to fulfil any of the conditions prescribed in the permission/recognition/affiliation accorded to that institution.

5. In this background and in exercise of the powers conferred under references cited, this show cause notice is being issued to the Society / College in the address entry to submit written statement / explanation why action should not be taken by withdrawing the permission or any other action as per

rules in vogue, by this Competent Authority for not running the College during the last three years and not complied with one of the conditions prescribed by this Competent Authority that the College should obtain affiliation of the University concerned and thereby denied the access to higher education to all sections of the society in the locality concerned and also not allowing other societies to impart higher education in the said location, which act is impermissible in law.

6. It is hereby directed to submit a written statement / explanation, on the following points, by the Society /College along with the copies of the permission proceedings issued by the Competent Authority to establish the College and affiliation orders of the university, within (1) month from the date of this notice to the Competent Authority.


- (xxvi) Purpose of taking permission by the Society for establishment of a new private unaided degree college in the locality concerned.
- (xxvii) Reasons for not complying one of the conditions to get affiliation from the concerned university immediately after receiving the provisional approval for establishment of a new degree college.
- (xxviii) Intention for not applying affiliation from the concerned university for a period of three years and thereby not running the college.
- (xxix) Reasons for violation of Rules prescribed by the Competent Authority and thereby denied the access of higher education to the students of various sections of the society in the locality concerned.
- (xxx) Any other statement / explanation as may be deemed necessary by the Society / College.

7. If written statement / explanation along with the documents specified above is not received within one month, it will be presumed/deemed that the College has no written statement / explanation to submit and accordingly the Competent Authority will take further action in the matter.

8. The Society / Management is given an opportunity to submit their written statement / explanation, as per rules in vogue, on the above points within the prescribed time, before passing orders by this Competent Authority.

9. It is hereby further directed that the College cannot make admissions into UG programmes for the academic year 2021-22 till the Competent Authority passes final orders on the written statement / explanation submitted by the Society / College.
